1. Every wrestler will wrestle each person in his or her bracket. (1 vs. 2, 3 vs. 4, 1 vs. 3, 2 vs. 4, 1 vs. 4, 2 vs.3)
2. Matches will consist of three, one-minute periods. Division V wrestlers will wrestle 2-1-1 minute periods.
3. IHSAA rules will be followed.
4. Anyone who causes damage to the school will be held responsible for such damage.
5. You are responsible for your own equipment and valuables.
6. Individual records throughout the day will determine place finishes in each bracket. If there is a tie in records between two or more wrestlers, the winner of head to head competition will break the tie. Black mark scoring will be used if there is still a tie.
