FORMAT:

- Round Robin Bracketing. Byes and pairing wrestlers from the same club will be avoided as much as possible.
- Division V will wrestle 2-1-1 periods. All other divisions will wrestle three 1-minute periods. Overtime: 1-minute. First take down wins. If a tie remains, a 30-second period from referee's position will be wrestled with the first point scored being the winner, or if the man on bottom does not get away, the top man is the winner.
- We will be using 7 mats.

AWARDS:

- Trophies will be given to all 1st place finishers. Medals will be given to 2nd – 4th place finishers.
- The "Rick Morris Award" will be given to the fastest pin in Divisions II - V. (There will be NO fastest pin award in Division I.)
